SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the SDS of this product.

By inhalation:

SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

Suitable extinguishing media:

5.2 Special hazards arising from the substance or mixture:

As a result of combustion or thermal decomposition reactive sub-products are created that can become highly toxic and, consequently, can present a serious health risk.

5.3 Advice for firefighters:

Depending on the magnitude of the fire it may be necessary to use full protective clothing and self-contained breathing apparatus (SCBA). Minimum emergency facilities and equipment should be available (fire blankets, portable first aid kit,...) in accordance with Directive 89/654/EC.

Cleans perfectly, leaves pleasant and long-lasting scent. Let the surface air-dry after cleaning.

Two ways to use:

- Use undiluted liquid for removing heavy dirt. After washing, allow to dry. No need to rinse ..
- For minor soiling is recommended to use diluted liquid (Three-nut-90ml in half a bucket of water about 5 l) to clean surfaces such as flooring (varnished wood, ceramic and plastic - including PVC), walls, tiles the panels. After washing, allow to dry. No need to rinse
